Note 1	Pursuant to Section 248 of the <i>Building Act 1993</i> , a person must not act on behalf of an owner of a building or land for the purpose of making any application, appeal or referral under this <i>Act</i> or the regulations unless the person is authorised in writing by the owner to do so.											
Note 2	If you are an owner-builder there are restrictions on the sale of the building under Section 137B of the <i>Building Act 1993</i> . Section 137B prohibits an owner-builder from selling a building on which domestic building work has been carried out within 6½ years from the completion of the relevant building work unless they have satisfied certain requirements including obtaining compulsory insurance.											
Note 3	If the builder is carrying out domestic building work under a major domestic building contract, attach an extract of the major domestic building contract showing the names of the parties to the contract in relation to the proposed building work and a copy of the certificate of insurance (if applicable).											
Note 4	The use of the building may also be subject to additional requirements under other legislation such as the <i>Liquor Control Reform Act 1998</i> and the <i>Dangerous Goods Act 1985</i> .											
Note 5	Building practitioner means: a) a building surveyor; or b) a building inspector; or c) a quantity surveyor; or d) an engineer engaged in the building industry; or e) a draftsperson who carries on a business of preparing plans for building work or preparing documentation relating to permits or permit applications; or f) a builder; including a domestic builder; or g) a person who erects or supervises the erection of prescribed temporary structures; or h) a person responsible for a building project or any stage of a building project and who belongs to a class of people prescribed to be building practitioners; but does not include - i) an architect; j) a person (other than a domestic builder) who does not carry on the business of building.											
Note 6	Include building practitioners with continuing involvement in the building work.											
Note 7	Include only building practitioners with no further involvement in the building work.											
Note 8	It is an offence pursuant to Section 78 of the <i>Building Act 1993</i> to appoint another person as the relevant building surveyor if a building surveyor has already been appointed for the project.
